## Today's Safety Challenges

Utah's citizens face unprecedented safety challenges today. Manmade materials used in building construction and furnishings burn fast and hot, creating unpredictable and highly lethal gases. Medical emergencies such as heart attack affect people daily. As Utah's population continues to increase, so does the potential from threats such as hazardous materials, accidents and violence.

Most people go about their business in their daily lives and seldom, if ever, have contact with any of this, except maybe driving by or seeing something in the news. But our firefighters confront these emergencies all the time as they respond to the front lines.

## The Proactive Spirit

A big part of a firefighter's job involves helping citizens in times of crisis, such as the tragic loss of a loved one in a vehicle accident or the loss of home and belongings to a fire.

Working with these people helps motivate firefighters to act proactively to find new ways to prevent and deal with emergencies.

Utah's firefighters also draw on their interactions with their counterparts from around the state and the nation in classes, conventions, conferences and in work situations such as FEMA deployments. Motivation, a wealth of experience, plus access to important, up-to-date

information have spurred many activities that benefit safety and quality of life in our state. Improvements from this proactive approach include better planning, more effective laws and regulations, safer working conditions, and training and education programs for the public and firefighters.

This proactive spirit was a major inspiration for the Utah Fire Caucus.

## An Invitation to All Utah Legislators

The non-partisan Utah Fire Caucus was formed in 2004. It is modeled after the very successful Congressional Fire Service Caucus (CFSC), established in 1987 in Washington, D.C., by former Congressman Curt Weldon. It is among the largest caucuses in the U.S. Congress with over 320 members. The CFSC does not require members to take sides on issues, but only to "pledge support in a way that best benefits fire departments in their respective Congressional districts."

The CFSC is supported by the Congressional Fire Services Institute (CFSI), a non-partisan, non-profit organization of fire service and trade groups and organizations. Its mission is to provide "services and programs to engage members of Congress in fire and life safety issues."

In Utah, the Joint Council of Fire Service Organizations is structured similarly. Diverse Utah fire service interests come together in this 20-year-old organization, which serves as an information conduit for the Utah Fire Caucus.

**The Utah Fire Caucus invites all Utah legislators to participate with our state's firefighters in this proactive organization.** The big winners will be the citizens in our communities who we are all dedicated to protect and serve.
